Description of how strategy/strategies will provide

All students are provided with the strategies to meet the challenging Missouri Learning Standards through a school-wide RTI program focused on needs using classroom data to guide instruction. All students have access to additional services in the Title I programs in reading. Some students are served in a pull-out model and some in a push-in model.

- Use methods and instructional strategies that strengthen the academic program in the school.

Description of how strategy/strategies will strengthen

1. Students are instructed in small reading groups based on their independent reading level. This is considered Tier 2 and 3 instruction and groups are no more than 3:1 student/teacher ratio.
2. Whole group instruction with peer modeling
3. Guided reading groups
4. Small reading groups based on skill needs
5. Data driven groups

Description of how strategy will provide

Students who need enrichment or accelerated curriculum can have their needs met during RTI in a group that has accelerated past the current grade placement. They also have their needs met in their individualized reading groups within the classroom.

Description of how strategy/strategies will address

Students, particularly those at risk of not meeting the Missouri Learning Standards, are taught with research based strategies. In reading, those strategies are in line with the Missouri Reading Initiative which provides onsite teacher training in strategies to teach and assess reading and writing. Those strategies include guided reading groups, teacher modeling, peer modeling, word work, and ongoing progress monitoring.

Our counseling department conducts lessons on planning for postsecondary education and workforce using the Missouri Connections program for our 6th, 7th, and 8th grade students. We also have a STEM program for our 6th, 7th, and 8th grade students. Fairview is a K-8 district so we do not provide coursework for postsecondary credit or offer career/technical education programs.

In order to assist preschool students in the transition from early childhood to elementary programs, Fairview should continue offering summer school to incoming kindergarteners. These students become aware of school procedures related to lunch, special classes, and location of building features. In addition, Fairview will continue to identify and serve preschool age students who qualify for special education services.
